



REDCAR AND CLEVELAND BOROUGH COUNCIL (OFF STREET PARKING PLACES) CONSOLIDATION ORDER 2003 (AMENDMENT) ORDER NO 1 2023

The Council has made an Order under the Road Traffic Regulation Act 1984 which will amend the Redcar and Cleveland Borough Council (Off Street Parking Places) Consolidation Order 2003 by adding Cat Nab Overflow Car Park to it making it a pay and display car park with the following charges:-

Monday to Sunday inclusive between 8am and 6pm £2.50 for up to 1 hour, £3.50 for up to 2 hours, £4.50 for up to 3 hours and £6.00 to park all day.

If you wish to question the validity of the Order or any provision in it on the ground that it is not within the powers conferred by the Act or on the ground that any requirement of the Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 21.4.23 apply to the High Court for that purpose.

The Council of the Borough of Redcar and Cleveland (hereinafter called the "the Council") in exercise of its powers under Section 35(1) and (3) and of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "The Act") and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act , hereby makes the following Order:-

1. This order shall come into operation on the first day of May 2023 and may be cited as the Redcar and Cleveland Borough Council (Off Street Parking Places)(Consolidation)(Amendment)Order (No 1)2023
2. The Redcar and Cleveland Borough Council(Off Street parking Places)(Consolidation)Order 2003 ("the Order") is hereby amended as follows:-
