#### Urgent - General Exception - Reasons for urgency outlined below

Redcar & Cleveland Borough Council submitted an application for funding under Phase 3b Public Sector Decarbonisation Scheme, October 2022. The council was notified of a successful £544,297 bid on 01/03/2023. Due to the timescales an urgent general exception is required. Equipment orders must be placed by the end of April. This will allow sufficient time for all parts to be delivered before the summer holiday begins. All installation works must be completed during the summer holiday period so as not to disrupt the school operation during term time.

The school will benefit from full conversion of the heating system to Air Source Heat Pump with electric back up heating as well as improvements to the buildings management system.

#### Background to decision:

Redcar & Cleveland Borough Council has successfully bid for funding from Salix (Phase 3b PSDS) totalling £544,297.00. Match funding of £77,170.92 will be provided from the School Condition pot (DFE grant for maintained schools)

This project supports the council's climate policy of achieving carbon neutrality by 2030. Highcliffe Primary will be the first site in the Borough that will be heated from 100% Air Source Heat Pumps (ASHPs). This means the school will be able to report that they are a net zero building, based on zero consumption of natural gas and the zero carbon for business electricity tariff which the school currently have in place.

Phase 3b PSDS project work must be completed by 31st March 2024. However due to the size of the works and nature of the building, all works will be completed over the 2023 summer holidays.

The project will see the installation of the measures detailed below at Highcliffe Primary School over the 2023 summer holiday period in readiness for the start of the 2023/24 academic year.

As part of the funding application process a scope of works was provided which includes:

#### **Decision Considerations:**

Contract Procedure Rules.

An upgrade to the school heating system is due, but without this grant funding would be a traditional gas-fired system with the associated carbon emissions.

Terms and Conditions of the Procurement for Housing - Renewables & Energy Efficiency Works and Associated Consultancy Framework apply.

#### Full details of decision:

Approval is requested to call off, via direct award, to Cenergist, for the provision of the decarbonisation project at Highcliffe Primary School.

Cenergist are first ranked on Lot 1c – Air Source Heat Pumps under the Procurement for Housing 'Renewables & Energy Efficiency Works and Associated Consultancy Framework'.

#### Financial detail:

The overall value of the contract delivery of the decarbonisation works will not exceed the Salix (Phase 3b PSDS) totalling £544,297.00 and match funding of £77,170.92 that will be provided from the School Condition pot (DFE grant for maintained schools).

#### **Delivering Social Value:**

This project will reduce emissions from a school sat within the community it serves. It is essential in the decarbonisation journey that all individuals and organisations do whatever they are able to reduce their own emissions, and this project will serve as a positive example to the children attending the school and their families.

#### **Reasons for Decision:**

The appointed contractor has a proven track record in delivery of schemes of this type and scale. This gives the best possible opportunity of delivering according to prescribed timescales.

#### Details of alternative options considered (if any) and reasons for rejection:

Do nothing – rejected as Salix Funding has been awarded to the Council to carry out the Phase 3b Public Sector Decarbonisation Scheme (PSDS).

Carry out the works internally – rejected as insufficient expertise and resource.

Carry out a competitive procurement process – rejected as the above Framework meets the Council's requirements.
