

**REDCAR AND CLEVELAND BOROUGH COUNCIL(A171 MIDDLESBROUGH ROAD
GUISBOROUGH) PROHIBITION OF U TURNS ORDER 2023**

The Council has made an Order under Sections 1, 2 and 4 and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 which prohibits any vehicle other than emergency services vehicles from making a U turn manoeuvre on A171 Middlesbrough Road Guisborough between the junction with Flatts Lane and the Windlebridge roundabout.

If you wish to question the validity of the Order or any provision in it on the ground that it is not within the powers conferred by the Act or on the ground that any requirement of the Act or of any Instrument made under it has not been complied with in relation to them, you may, within 6 weeks from 25.8.23 apply to the High Court for that purpose.

STATEMENT OF REASONS

A new development, Wyke Lodges is currently under construction on the south side of A171, in order to maintain road safety in this area it is proposed to introduce a restriction on U turns to prevent drivers performing this manoeuvre in order to access Wyke Lodges or The Cross Keys.

THE COUNCIL OF THE BOROUGH OF REDCAR AND CLEVELAND in exercise of its powers under Sections 1,2,and 4 and part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 HEREBY MAKES THE FOLLOWING ORDER:-

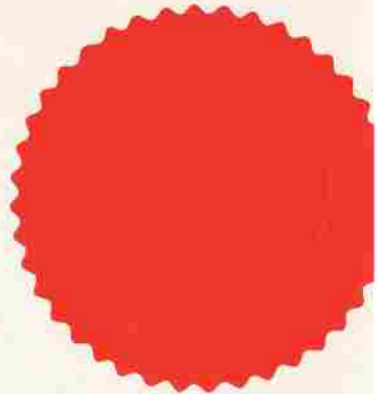
1. This Order shall come into operation on the 4th day of September 2023 and may be cited as the Redcar and Cleveland Borough Council (A171 Middlesbrough Road Guisborough) Prohibition of U Turns Order 2023.
2. Save as provided in Article 3 of this Order no person shall cause or permit any vehicle proceeding on A171 Middlesbrough Road Guisborough to make a "U" turn, so as to proceed in the opposite direction on A171 Middlesbrough Road Guisborough between its junction with Flatts Lane to its junction with Windlebridge Roundabout.
3. Nothing in Article 4 of this Order shall apply to any vehicle being used for police, fire or ambulance service purposes in the circumstances of an emergency.
