**GUISBOROUGH(WAITING AND LOADING AND PARKING PLACES)CONSOLIDATION ORDER 2003
(AMENDMENT)ORDER NO 1 2023**

The Council has made an Order under the Road Traffic Regulation Act 1984 the effect of which will be to amend the Redcar and Cleveland Borough Council (Guisborough)(Waiting and Loading and Parking Places)Consolidation Order by introducing a charge rate for 1 hour's parking at the cost of £1.10 in A173 layby carpark at Newton under Roseberry The existing charges of £2.20 for 2 hours, £3.30 for 3 hours and £4.40 for all day will remain.

If you wish to question the validity of the Order or any provision in it on the ground that they are not within the powers conferred by the Act or on the ground that any requirement of the Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 5.9.23 apply to the High Court for that purpose.

STATEMENT OF REASONS

It is proposed that a 1-hour parking tariff is provided at A173 layby – Newton Under Roseberry, to provide users with greater flexibility and accommodate those users wishing for a shorter stay, the current tariff only allows for a minimum of 2 hours.

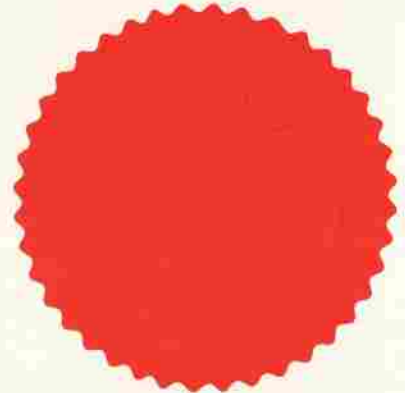
The Council of the Borough of Redcar and Cleveland (hereinafter referred to as "the Council") under Sections 1, 2, 4, 32, 35, 45, 47, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby makes the following Order.

1. This Order shall come into operation on the eleventh day of September 2023, and may be cited as the Redcar and Cleveland Borough Council (Guisborough) (Waiting, Loading and Parking Places) (Consolidation) (Amendment) Order (No. 1) 2023.
2. The Redcar and Cleveland Borough Council (Guisborough) (Waiting and Loading and Parking Places) (Consolidation) Order 2003 ("the Order") is hereby amended as follows:-
 - (a) By deleting the following from Column 7 Scale of Charges in Schedule 5 On Street Pay and Display Parking A173 Layby Newton under Roseberry :-
£2.20 for 2 hours, £3.30 for 3 hours £4.40 all day.
 - (b) By adding the following into Column 7 Scale of Charges in Schedule 5 On Street Pay and Display Parking A173 Layby Newton under Roseberry:-
£1.10 for 1 hour, £2.20 for 2 hours, £3.30 for 3 hours, £4.40 all day
