OFF STREET PARKING PLACES CONSOLIDATION ORDER 2003 AMENDMENT ORDER NO 2 2023

The Council has made an Order under the Road Traffic Regulation Act 1984 (the Act") the effect of which will be to amend the Redcar and Cleveland Borough Council (Off Street Parking Places) Consolidation Order 2003 ("the Order") as follows:-

- a. By deleting the following from the Off Street Car Park Schedule ("the Schedule") Column 7 Scale of Charges in respect of Cowbar Lane Car Park 08:00-18:00 hours ,2 hours £2.00.3 hours £3.00,4 hours £4.00 ,Over 4 hours £6:00 , 18:00-08:00 hours overnight charge £15.00.
- b. By adding the following into Column 7 Scale of Charges in the Schedule in respect of Cowbar Lane Car Park 06:00- 20:00 hours, 1 hour £2.20, 2 hours £4.00, 3 hours £5.00, Over 3 hours up to 20:00 £6:50 20:00- 06:00 hours overnight charge £15.00.
- c. By redesignating Graffenburg Street Car Park as a Long Stay Car Park
- d. By deleting the days of operation in Column 4 of the Schedule in respect of Graffenburg Street Car Park (Monday to Saturday inclusive)
- e. By inserting into Column 4 of the Schedule Days of Operation of Car park in respect of Graffenburg Street Car Park Monday to Sunday inclusive
- f. By deleting from Column 6 of the Schedule in respect of Graffenburg Street Car Park the words "2 hours maximum per calendar day. Only one stay of 2 hours permitted in any calendar day per vehicle
- g. By adding into Column 6 of the Schedule in respect of Graffenburg Street Car Park the words "No Limit".
- h. By deleting from Column 7 Scale of Charges of the Schedule in respect of Graffenburg Street Car Park the following words; Two hours free, only one stay permitted in any calendar day per vehicle
- i. By adding into Column 7 Scale of Charges of the Schedule in respect of Graffenburg Street Car Park the following 1 hour £1.10, 2 hours £2.20, 3 hours £3.30, Over 4 hours £4.40
- j. By deleting from Column 6 of the Schedule the maximum period of two hours for which vehicles may wait in respect of West Dyke Road North Car Park.
- k. By deleting the following from Column 7 of the Schedule in respect of West Dyke Road North Car Park 1 hour £1.50, 2 hours £2.50 Max stay 2 hours
- I. By inserting the following into Column 7 of the Schedule in respect of West Dyke Road North Car Park 1 hour £1.60, £2.20 each additional hour
- m. By deleting from Column 6 of the Schedule in respect of Fountain Street East, Reid Terrace, Church Square and Muriel Street Car Parks the words "2 hours maximum per calendar day. Only one stay of 2 hours permitted in any calendar day per vehicle
- n. By adding into Column 6 of the Schedule in respect of Fountain Street East, Reid Terrace, Church Square and Muriel Car Parks the words "No Limit"

- o. By deleting from Column 7 Scale of Charges of the Schedule in respect of Fountain Street East, Reid Terrace, Church Square and Muriel Street Car Parks the following words; Two hours free, only one stay permitted in any calendar day per vehicle
- p. By adding into Column 7 Scale of Charges of the Schedule in respect of Fountain Street East, Reid Terrace, Church Square and Muriel Street Car Parks the following 1 hour £1.60, £2.20 each additional hour
- q. By deleting from Column 6 of the Schedule in respect of Fountain Street Coach Park the words "2 hours maximum per calendar day. Only one stay of 2 hours permitted in any calendar day per vehicle
- r. By adding into Column 6 of the Schedule in respect of Fountain Street Coach park the words "No Limit"
- s. By deleting from Column 7 Scale of Charges of the Schedule in respect of Fountain Street Coach Park the following words; Two hours free, only one stay permitted in any calendar day per vehicle
- t. By adding into Column 7 Scale of Charges of the Schedule in respect of Fountain Street Coach Park the following First 2 hours free , £2.20 each additional hour
- u. By deleting the days of operation in Column 4 of the Schedule in respect of King Street Car Park (Monday to Saturday inclusive)
- v. By inserting into Column 4 of the Schedule Days of Operation of Car park in respect of King Street Car Park Monday to Sunday inclusive
- w. By deleting from Column 6 of the Schedule in respect of King Street Car Park the words "2 hours maximum per calendar day. Only one stay of 2 hours permitted in any calendar day per vehicle
- x. By adding into Column 6 of the Schedule in respect of King Street Car Park the words "No Limit".
- y. By deleting from Column 7 Scale of Charges of the Schedule in respect of King Street Car Park the following words; Two hours free, only one stay permitted in any calendar day per vehicle
- z. By adding into Column 7 Scale of Charges of the Schedule in respect of King Street Car Park the following 1 hour £1.60, £2.20 each additional hour
- aa. By deleting the existing charges from Column 7 Scale of Charges in respect of Rainbow Lane Carpark and adding the following:- 1 hour £1.60 , £2.20 each additional hour

If you wish to question the validity of the Order or any provision in it on the ground that it is not within the powers conferred by the Act or on the ground that any requirement of the Act or of any Instrument made under it has not been complied with in relation to it, you may, within 6 weeks from 6.11.23 apply to the High Court for that purpose.

THE REDCAR AND CLEVELAND BOROUGH COUNCIL (OFF STREET PARKING PLACES) (CONSOLIDATION)AMENDMENT ORDER No 2 2023

The Council of the Borough of Redcar and Cleveland (hereinafter called "the Council") in exercise of its powers under Section 35(1) and (3) and of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order :-

- 1. This Order shall come into operation on the eight day of January 2024 and may be cited as the Redcar and Cleveland Borough Council (Off Street Parking Places)(Consolidation) Amendment Order No 2 2023.
- The Redcar and Cleveland Borough Council (Off Street Parking Places)(Consolidation)Order 2003 ("the Order") is hereby amended as follows :-
- a. By deleting the following from the Off Street Car Park Schedule ("the Schedule") Column 7 Scale of Charges in respect of Cowbar Lane Car Park

08:00-18:00 hours 2 hours £2.00 3 hours £3.00 4 hours £4.00 Over 4 hours £6:00 18:00-08:00 hours overnight charge £15.00

b. By adding the following into Column 7 Scale of Charges in the Schedule in respect of Cowbar Lane Car Park

06:00- 20:00 hours 1 hour £2.20 2 hours £4.00 3 hours £5.00 Over 3 hours up to 20:00 £6:50 20:00- 06:00 hours overnight charge £15.00.

- c. By redesignating Graffenburg Street Car Park as a Long Stay Car Park
- d. By deleting the days of operation in Column 4 of the Schedule in respect of Graffenburg Street Car Park (Monday to Saturday inclusive)
- e. By inserting into Column 4 of the Schedule Days of Operation of Car park in respect of Graffenburg Street Car Park Monday to Sunday inclusive
- f. By deleting from Column 6 of the Schedule in respect of Graffenburg Street Car Park the words "2 hours maximum per calendar day. Only one stay of 2 hours permitted in any calendar day per vehicle
- g. By adding into Column 6 of the Schedule in respect of Graffenburg Street Car Park the words "No Limit".

- h. By deleting from Column 7 Scale of Charges of the Schedule in respect of Graffenburg Street Car Park the following words;
- Two hours free, only one stay permitted in any calendar day per vehicle i. By adding into Column 7 Scale of Charges of the Schedule in respect of Graffenburg Street Car Park the following

1 hour £1.10 2 hours £2.20 3 hours £3.30 Over 4 hours £4.40

- j. By deleting from Column 6 of the Schedule the maximum period of two hours for which vehicles may wait in respect of West Dyke Road North Car Park.
- k. By deleting the following from Column 7 of the Schedule in respect of West Dyke Road North Car Park

1 hour £1.50 2 hours £2.50 Max stay 2 hours

I. By inserting the following into Column 7 of the Schedule in respect of West Dyke Road North Car Park

1 hour £1.60 \pounds 2.20 each additional hour

- m. By deleting from Column 6 of the Schedule in respect of Fountain Street East, Reid Terrace, Church Square and Muriel Street Car Parks the words "2 hours maximum per calendar day. Only one stay of 2 hours permitted in any calendar day per vehicle
- n. By adding into Column 6 of the Schedule in respect of Fountain Street East, Reid Terrace, Church Square and Muriel Car Parks the words "No Limit"
- By deleting from Column 7 Scale of Charges of the Schedule in respect of Fountain Street East, Reid Terrace, Church Square and Muriel Street Car Parks the following words;

Two hours free, only one stay permitted in any calendar day per vehicle

- u. By deleting the days of operation in Column 4 of the Schedule in respect of King Street Car Park (Monday to Saturday inclusive)
- v. By inserting into Column 4 of the Schedule Days of Operation of Car park in respect of King Street Car Park Monday to Sunday inclusive
- w. By deleting from Column 6 of the Schedule in respect of King Street Car Park the words "2 hours maximum per calendar day. Only one stay of 2 hours permitted in any calendar day per vehicle
- x. By adding into Column 6 of the Schedule in respect of King Street Car Park the words "No Limit".
- y. By deleting from Column 7 Scale of Charges of the Schedule in respect of King Street Car Park the following words; Two hours free, only one stay permitted in any calendar day per vehicle
- z. By adding into Column 7 Scale of Charges of the Schedule in respect of King Street Car Park the following 1 hour £1.60 £2.20 each additional hour
- aa. By deleting the existing charges from Column 7 Scale of Charges in respect of Rainbow Lane Carpark and adding the following:-1 hour £1.60 £2.20 each additional hour

STATEMENT OF REASONS

Following the end of the TVCA funding to provide 2 hours free parking in council short stay car parks and on street locations, amendments to the off street and Redcar WLP traffic regulation orders are required. The amendments are required to remove the free 2 hours parking provision and re-introduce charges.

Slight amendments are also required to the days/times of operation at the King Street and Cowbar car parks to allow for a better operation for users and Graffenberg Street is to be changed to Long Stay from Short stay to allow this to be utilised by users wishing for a longer parking duration.
