It offers a wheelchair accessible entrance; however, it is narrow and does not facilitate flat access despite the offer of ramps. The location itself is ideal but requires some minor adjustments to ensure it is fully compliant	ERO Comment Conversations have taken place with contacts at the Methodist Church. An alternative entrance into the venue, which is more accessible has been identified and will be trialed at the next elections. ERO reply Thank you for your comments relating to polling venues in the St Germain's Ward which were submitted as part of the Polling District and Polling Places Consultation. I am pleased to hear that Marske Leisure Centre is fully accessible and can confirm that we will continue to use that venue. We are unable to preempt candidacy for future elections, however we do have other polling venues across the borough for which the lease holder, booking agent, key holder or caretaker is either a serving elected member or a previous candidate or elected member.
