  - 1 hour £1.30, 2 hours- £2.60, 3 hours £4.00, All day £5.30
- d. By changing West Dyke Road North Car Park from Short Stay to Long Stay and amending the charges to the following: -

1 hour -£1.00 , All day- £2.50
