

## REDCAR AND CLEVELAND BOROUGH COUNCIL

## WOMEN'S TOUR OF BRITAIN CYCLE RACE (TEMPORARY TRAFFIC REGULATION) ORDER 2025

Not less than 7 days herefrom the Council intends to make an Order under the Road Traffic Regulation Act 1984 to facilitate the holding of a relevant event .

The effect of the Order will be to: -

- 1. Prohibit any vehicle from entering onto or proceeding in the lengths of road as specified in the Schedule below
- 2. Prohibit any vehicle from stopping or waiting (including for the loading and unloading of goods) in the lengths of road as specified in the Schedule below.
- 3. The above prohibitions shall not apply to any vehicle officially accredited to the event, any vehicle used for the removal of any obstruction to traffic, any vehicle used by the emergency services or any vehicle used in pursuance of statutory powers or duties.
- 4. To suspend the existing speed limit on the lengths of road specified in the Schedule during the periods when the prohibition in clause 1 above is in operation and impose the national speed limit for those vehicles specified in clause 3 above.

The Order will come into effect on 5.6.25 but will only be operative between whilst the Council or a person authorised on its behalf displays the relevant traffic signs or as indicated by a Police Officer in uniform.

Stage One – 5<sup>th</sup> June 2025 (Rolling Road Closures) 05:00 hours to 15:00hours

A173 from North Yorkshire Boundary to Stokesley Road, Guisborough; Stokesley Road Guisborough; Middlesbrough Road, Guisborough; Park Lane, Guisborough; Bolckow Street, Guisborough; Church Lane (A173) Guisborough; Skelton Ellers (A173);B1268 Ellers Bank;A174 from B1268 to A1085;A1085 Marske;High Street, Marske;A1085 Coast Road;Coast Road from Zetland Roundabout to Lilac Grove;The Crescent, Redcar;Granville Terrace, Redcar;Lord Street to junction with Lime Road, Redcar; Lime Road to junction with Granville Terrace, Redcar;and all junctions thereon

Stage Two – 6<sup>th</sup> June 2025 (Rolling road closures) 05:00hours to 15:00 hours except for Glenside and Albion Terrace which will be closed 05:00 hours to 18:00 hours

A173 from North Yorkshire Boundary to Stokesley Road, Guisborough; Stokesley Road, Guisborough; Middlesbrough Road, Guisborough; West End, Guisborough; Westgate, Guisborough; Church Street, Guisborough; Redcar Road, Guisborough; Church Lane (A173) Guisborough; Skelton Ellers (A173); B1268 Ellers Bank; A174 to Marske Lane; Marske Lane, Skelton; Green Road, Skelton; Boosbeck Road, Boosbeck; High Street, Boosbeck; Lingdale Road; High Street, Lingdale; Kilton Lane; Kilton Thorpe Lane; A174 to Brotton Road Roundabout; Lorne Terrace, Brotton; Saltburn Road; Glenside Saltburn;

Albion Terrace to junction with Leven Street, Saltburn; Victoria Terrace, Saltburn; Marske Mill Lane, Saltburn; Guisborough Road, Saltburn; and all junctions thereon
