**For Families and Social Workers**

# Eligibility for Specialist Short Breaks

**0 – 18 years, may extend to 25 years if there is an assessed need for services to continue**

Sometimes a child or young person may have more significant or complex needs due to their disability and will need more specialist support than what is available via universal or targeted services. To identify if there is a need for specialist Short Breaks a social worker will undertake an assessment which will consider the following:

- The identified needs are as a direct result of the child's disability i.e are not due to family dynamics or economic resources
- The degree of care, supervision and support required to meet their needs are much greater than that usually required to meet the needs of children and young people of the same age
- The identified needs cannot be met in any other way through universal, targeted or family support/provision

The assessment will include a minimum of one home visit by an allocated social worker. Checks with other health, care and education professionals involved with the child/young person and their family will also be undertaken.

During the assessment, the social worker will work with the family to identify what support is needed. This could be referrals to other agencies that can offer specialist advice and support or this could be in the form of a funded package of support. Any identified funded package of support will be presented to the Children with Disabilities Multi Agency Panel for consideration.

The support provided may include one or a number of services such as; a personal assistant, support in the family home, specialist group/club provision, overnights away from the family home. These services will be commissioned specifically for the child's/young person's needs or alternatively a family may choose to take a Direct Payment to arrange the services themselves.

Any services provided will be regularly reviewed in line with the child's needs. This means that support can increase, decrease or cease.

## **Children and Young People's Continuing Care**

Some children and young people (up to age 18), may have very complex health needs and may be eligible for continuing care.

These may be the result of:

- congenital conditions
- long-term or life-limiting conditions
- disability
- serious illness or injury

The Integrated Care Board (ICB) has responsibility for assessing children and young people to see if they need a package of continuing care. A referral can be made by any health professional, social worker or carer who feels a continuing care package may be required. When a child or young person is referred for an assessment, the ICB might first check if they are likely to need a full assessment.

A health assessor will then collect evidence of the child's needs, drawing on the advice of health and care professionals. An important part of the assessment is to capture the preferences of the child or young person and their family. The assessment will look at the current care being provided but a decision on whether or not a child or young person has a continuing care need is based on the nature of their needs, rather than the care available, or whether or not they have a particular condition.

The health assessor will make a case to a panel of experts, who decide based on the evidence, and the recommendation, if the child or young person has a continuing care need.

Depending on the decision, a package of care is then agreed; some of this care may be provided through existing services such as Short Breaks; some may need to be specially arranged.



	<p>All staff have been trained in psychosocial interventions, low level DBT management, low level CBT approach skills, LOW AROUSAL, managing Psychosis and hearing voices, techniques to managing hearing voices, Gender identity in children, Ligature face to face training, PACE training, Mental health act, Staff have experienced working with young people subject to DOLS in the community.</p> <p>All staff have additionally received training around crisis intervention and crisis responses which highlights the need to prevent hospital admissions or repeat hospital admissions.</p> <p>Additionally, all staff are ARC trained which looks at the least restrictive approach to care, trauma informed care, managing behaviours that challenge and personal protection techniques.</p> <p>All young people we support are given a clinical lead that over see's the staff and offers supervision, team meetings, training, resilience training, compassion fatigue training and clinical lead will liaise with social worker, health services, police etc.</p> <p>The clinical lead will provide Philomenia protocol, PBS, care plan, risk assessments, About me, activities planner and food planners, the lead will research the area and support education, support activities to fill in the young persons time and promote relationships and social inclusion.</p> <p>A weekly report will be produced and sent to social worker and children's placement which will highlight PBS, activities, medication concordance, presentation, Mental state examination, Sleep hygiene, Nutritional support, social inclusion, education, hobbies, young person's wants wishes and feelings, overview of staff's thoughts on how the week has been, clinical lead impression, young person's self-care and routine.</p> <p>The combination of this specialised training along with the provision of stable and consistent staffing is vital in fostering a deep comprehension of the young person's needs. 



<b>Overview of provision:</b>	<p>Much of the support offered at Zoë's Place is short breaks care. All the babies and Children that attend the Hospice have a life-limiting or life-threatening conditions and complex health needs.</p> <p>The team comprise of registered nurses and experienced care assistants that can care for an array of health needs. We are fortunate to have a wonderful sensory room and soft play at the hospice which can be enjoyed by the children.</p> <p>Zoë's Place offers our parents and carers a chance to recharge their batteries or to spend time with their other children. The value of these short breaks to our families cannot be underestimated and many families tell us that they simply would not be able to cope without the help and support of our team.</p> <p>Alongside the care that we offer to the children we also support the whole family with support through our parent support and the sibling groups. We also provide a counselling accessible to all parents.</p>

## Direct Payments

If the Children with Disabilities Multi Agency Panel agrees, you may choose to have some or all of your child's care and support costs paid to you as a Direct Payment. A Direct Payment enables you to make decisions about the provision of care and support such as employing a personal assistant.

There are lots of advantages to employing someone to help with your child's care and support, but being an employer is a big responsibility and there are lots of things to consider.

## Baysdale Short Breaks Service Tees and Esk Wear Valleys NHS Foundation Trust



Baysdale provides short break respite care to children and young people with learning disabilities and associated healthcare needs. Baysdale is located at Roseberry Park Hospital in Middlesbrough and can be accessed by children and young people that live in Teesside.

Staff are trained to care for children with complex physical health needs such as gastrostomy feeding, as well as providing a stable and predictable environment for autistic children and young people and those with ADHD.

Eligible children and young people will be offered 2 overnight stays per month.
