**THE REDCAR & CLEVELAND BOROUGH COUNCIL COWBAR OPEN SPACE PUBLIC SPACES
PROTECTION ORDER (PSPO) 2022 EXTENSION AND VARIATION ORDER**

On the 1st October 2022 Redcar & Cleveland Borough Council (the Council) being the appropriate local authority and in pursuance of its powers under the Anti-social Behaviour, Crime and Policing Act 2014, made a Public Spaces Protection Order (the original order) as described in the first schedule with extension and variations.

The Council, in its capacity as local authority and pursuance of s60 and s61 of the Anti-social Behaviour, Crime and Policing Act 2014 and all other enabling powers, makes the following order:

- 1 The original order is extended by 18 months expiring on **31st March 2027**.
- 2 The Plan is varied to exclude privately owned land at the request of the owner.

ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014

Redcar and Cleveland Borough Council (in this Order called The Council) hereby makes the following Order under section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014

- a) The effect of the Order will be to restrict the public from creating nuisance over the area shown in red on the attached map ("the Restricted Area")
- b) the Council is satisfied that the requirements of Section 59 in respect of the said highway are satisfied;
- c) and that it is expedient for the purposes of preventing or reducing crime and/or anti-social behaviour that public use of the said area be restricted.

THE SCHEDULE

In the area marked red on the attached map, any person who continues to carry out activities from which they are prohibited commits an offence namely:

- 1) No person shall deposit any litter anywhere within the Restricted Area other than in a receptacle intended for this purpose
- 2) No person, without reasonable excuse, shall urinate or defecate anywhere within the Restricted Area
- 3) No person shall deposit any human waste, including grey water or chemical toilet waste, anywhere within the Restricted Area other than in a facility designed for this purpose
- 4) No person shall light a fire, barbeque (including disposable barbeques), candle or stove of any type in the Restricted Area
- 5) No person shall place, throw or drop in the Restricted Area anything likely to cause a fire
- 6) No person shall act in such a way which causes or is likely to cause alarm, harassment, distress, or nuisance to the public, including people living in the locality, in particular shouting and swearing at, or abusing, threatening or otherwise intimidating (including by the use of sexual language or making sexual suggestions) another person

The Order will remain in force for a period of three years from the date of this Order, unless extended by further orders

A person guilty of an offence under section 67 of the Act is liable on summary conviction to a fine not exceeding level 3 on the standard scale or fixed penalty notice of a maximum

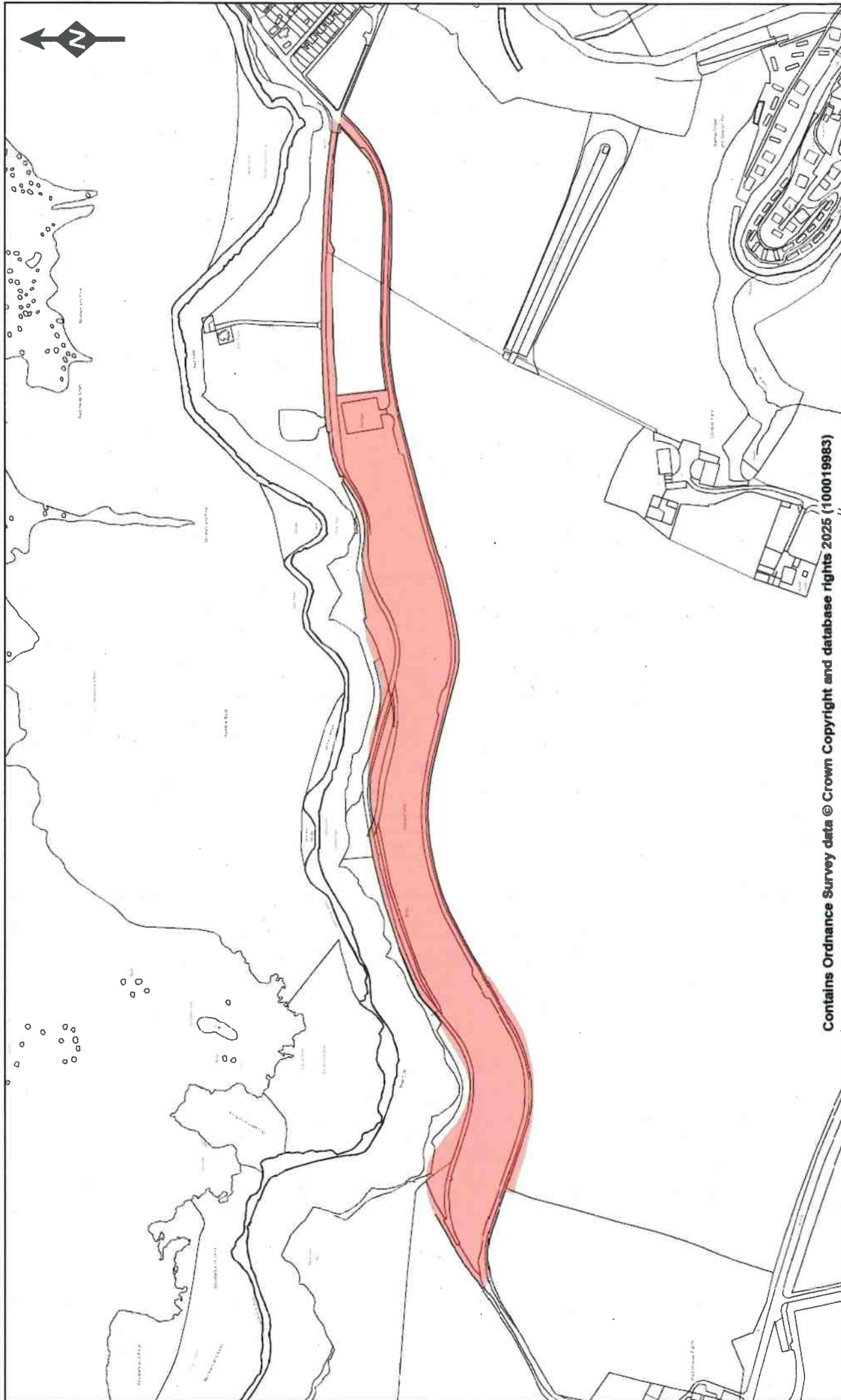
