


<u>Reason for urgency</u>	
There is special urgency around acceptance of this Capital grant funding as there is a very short timeframe to complete the works. RCBC will need to fund the improvements initially and costs will be reimbursed in arrears on production of proof of payment. Works and purchases must be completed and proof of payment supplied to the funder by 28th February 2026 to enable repayment before the end of the 25/26 financial year. The grant acceptance letters sent to us by DCMS need signing quickly, so that work can start on ordering the goods and services documented within each youth and community centre bid. Property Services can only start work when the capital funding receipt has been authorised, and there is a lot of work to do within 4.5 months and before the tight deadline of 28th Feb 2026, in order to draw down the funding from DCMS. It is not in the council or public's interest to add any unnecessary delay to accepting this grant funding and starting some of the bigger projects such as resurfacing the MUGA outside of 25K and a new kitchen at Guisborough and Loftus, in order to meet the tight timescales.

Background to decision:

In August 2025, the Department for Culture, Media and Sport published an opportunity to apply for capital funding to improve Youth Centres owned or leased by direct delivery Youth Services providers, including Local Authorities. The application process is being managed on the Department's behalf by Social Investment Business (SIB).

RCBC has made eight successful applications to the fund, with grants of £304,257.66 being won by the youth service team, to complete capital works and purchase equipment for our eight Youth and Community Centres, broken down as detailed in the financial detail section below:

A range of projects is proposed including installation of outdoor play equipment, redecorations, improvements to an outdoor multi-use games area and creation of mobile music production studios, DJ booths and a gaming area. Guisborough Youth Centre will be refurbished and specialist equipment installed to make it more suitable for young people with special needs and

disabilities as this centre is now mainly used to provide short breaks. The funding will have a positive impact on the experience of young people attending youth activities and will attract more young people to attend.

There is special urgency around acceptance of this grant funding as there is a very short timeframe to complete the work. RCBC will need to fund the improvements initially and costs will be reimbursed in arrears on production of proof of payment. Works and purchases must be completed and proof of payment supplied to the funder by 28th February 2026 to enable repayment before the end of the 25/26 financial year.

Decision Considerations:

The timeframe to spend the funding by end February 2026 is achievable as quotations have already been obtained for the works and equipment in preparation for the bid, and timeframes checked with the suppliers.

Suppliers include in-house property services department, and suppliers from framework agreements where a tendering exercise has already been carried out, which reduces the timescale for procurement.

As funding is payable in arrears, the finance department has confirmed that RCBC is able to pay for the works and equipment in advance and systems have been set up the monitor and manage expenditure to be able to easily prove payment.

Full details of decision:

On agreeing to accept the funding from DCMS, RCBC must comply with the following terms of use of grant as set out in the grant contract (as attached): (You = RBCB as the grant recipient)

1. The grant agreement shall commence on the date of signing of the offer letter and shall terminate on SIB's receipt of the end of Grant Monitoring Report from you or earlier in accordance with the terms of the agreement.
2. SIB will pay the grant payment to you upon receipt and approval of the payment request form and the grant payment evidence up to the total grant amount.
3. The eligible expenditure must conform and comply with the eligible expenditure principles in all respects.
4. The payment request form and grant payment evidence must be provided no later than 21 days prior to the relevant expected payment date. Failure to provide any payment request form and grant payment evidence by this deadline may lead to a delay in issuance of the relevant grant payment and in particular will mean SIB cannot make payment to you by the expected payment date.
5. The parties acknowledge that the expected payment date and expected amounts are estimates only.
6. All grant payments will be made in arrears. Any claim for a grant payment that has not been made by the grant end date and/or in accordance with clause 4 above will not be considered.

7. You must not make any change to the project objectives without SIB's prior written consent.
8. The grant funds must be spent in the grant period and must only be used to offset eligible expenditure and in the amounts correlating to each eligible expenditure entry as laid out in the grant details.
9. The grant funding shall not be applied except in accordance with clause 8.

Delivering Social Value: The funding will help to improve outcomes for young people by improving the range of activities the Local Authority can deliver to young people and increasing the number of young people the Local Authority Youth Service can reach by making Youth Centres more attractive to attend. Guisborough Youth Centre will be refurbished and equipped to make it more suitable for young people with special needs and disabilities, both through activities delivered by the Local Authority and by partner organisations from the voluntary sector, as short breaks.

Reasons for Decision:

Young People will be able to attend modern attractive youth centres, and take part in activities that interest them, contribute to their development and improve their future prospects through provision of up-to-date IT equipment and facilities. Improving our Youth Centres will attract more young people to attend our youth sessions and improve our Youth Workers' ability to deliver engaging youth club sessions. There is also a future cost saving to the local authority who would otherwise have had to refurbish and replace some of the equipment being grant-funded such as the MUGA at 25K which has suffered damage from fire setting, the kitchen and audio-

visual equipment at Loftus Y&C Centre; and some of the furniture being purchased for the centres.

Details of alternative options considered (if any) and reasons for rejection:

N/A - if not accepted, we will not be able to purchase the equipment and resources which our neighbourhood youth officers in collaboration with young people have identified would significantly enhance the 17 youth club sessions that run weekly across the borough from our youth and community centres, as there is no local authority budget for this capital work.


