


Urgent – General Exception - Reasons for urgency outlined below

The award is urgent to ensure that we meet the deadline in our procurement timetable to allow time for TUPE and to not have a gap in service provision (deemed Illegal services by Ofsted) between existing providers delivering the current service and new providers who may be successful.

A forward plan entry and commence a process DP were signed off in February 2025, however a week before we are to publish the tender opportunity Middlesbrough Council are now being named on the procurement and following consultation with the market the term was increased from 5 to 7 years the scope and value have changed so that it doesn't fit within the bounds of the original decision.

Background to decision:

There is a requirement for Ofsted Registered 16–17-year-old Supported Accommodation within Redcar and Cleveland to meet our statutory needs for 16-17 young people who are not in a Childrens Residential home or a Fostering Placement. This procurement will both bring together existing provision under a contract/pseudo-framework and support the increase for Redcar and Cleveland Council's accommodation offer to help meet our sufficiency needs for 16–17-year-old children in our care including separated migrant children. An increase in local provision for local children will also prevent children moving out of area and maintain children close to family and friends.

Redcar and Cleveland are the lead authority with Middlesbrough Council named on the tender as a further authority who may also use the pseudo-framework element of the contract. This request is to commence a procurement process.

<p>Full details of decision:</p> <p>Approval is requested to commence a procurement process to enter into individual contracts for up to 21 beds and spot purchase (we will only pay if we place) Framework Agreements for Ofsted registered 16–17-year-old Supported Accommodation services.</p> <p>The proposed term would be for 5 years commencing 1st April 2026 (or within a 6-month period subject to procurement time scales) with an optional extension period of 2 further years (this is following feedback received in the market engagement process).</p>	
<p>Financial detail:</p> <p>This procurement is to provide high quality local provision 16-17 supported living accommodation registered with Ofsted . Due to the procurement being a competitive tender, it is anticipated to see a reduction in spend from higher cost placements.</p> <p>Services are for 16-17 children in our care funded from existing budgets and separated migrant children who will be funded from Home Office Income.</p>

Reasons for Decision:

For the Council to meet its outcomes for Children and Young People and to meet Redcar and Cleveland Council accommodation sufficiency for children in our care to comply with section 20 and section 31 of the Children Act 1989.

This service will address the current gap of Ofsted registered supported living services for 16–17-year-olds within Redcar and Cleveland.

To support the council to meet its outcomes for Children and Young People we must look to continue our work in partnership with external providers to increase local sufficiency who have the skills and experience to deliver and operate Ofsted registered supported accommodation services.

The services will allow children and young people to remain in their locality, access local support services and amenities, maintain contact with family members, maintain their identity and plan appropriately for their transition to leave care.


Details of alternative options considered (if any) and reasons for rejection:




