The Council proposes to make an Order under the Road Traffic Regulation Act 1984 ("the Act") the effect of which will be to amend the Redcar and Cleveland Borough Council (Off Street Parking Places) Consolidation Order 2003("the Order") by creating a new car park for permit holders only at Redcar Central Station.

REDCAR AND CLEVELAND BOROUGH COUNCIL(OFF STREET PARKING PLACES)(CONSOLIDATION)(AMENDMENT) ORDER (No 1)2026

The Council of the Borough of Redcar and Cleveland (hereinafter called the “the Council”) in exercise of its powers under Section 35(1) and (3) and of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called “The Act”) and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act , hereby makes the following Order:-

1. This order shall come into operation on the day of 202 and may be cited as the Redcar and Cleveland Borough Council (Off Street Parking Places)(Consolidation)(Amendment)Order (No 1)2026

2. The Redcar and Cleveland Borough Council(Off Street parking Places)(Consolidation)Order 2003 (“the Order”) is hereby amended as follows:-

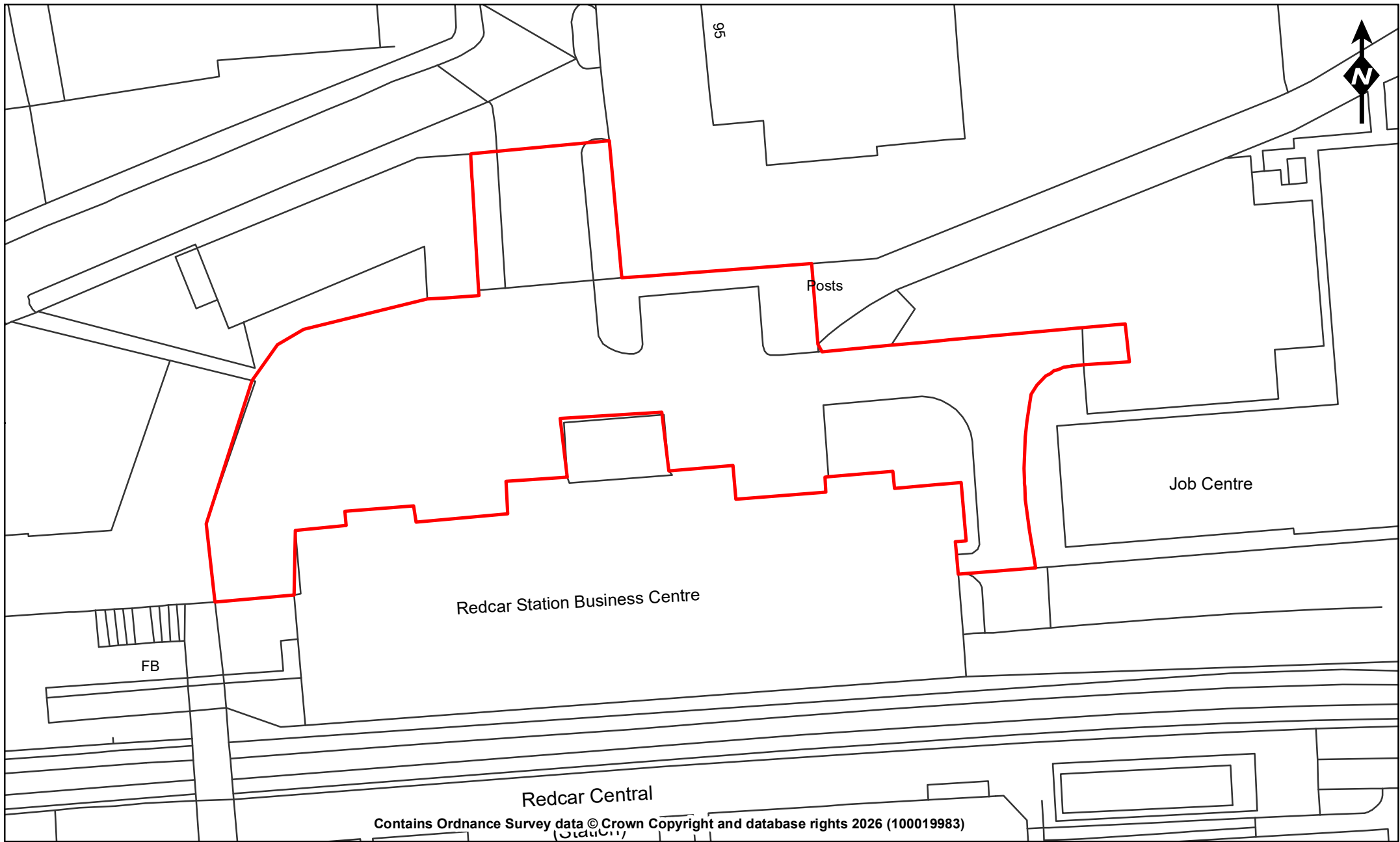

STATEMENT OF REASONS

The Council has taken on the lease of Redcar Central Station and within the demise sits the access and parking bays to the front of the building. With refurbishment works to the building due for completion in December the council require the ability to safely manage and enforce vehicular movement in this area. It is intended to designate the parking area as permit holders only for the benefit of building tenants and visitors. There is ample public parking in the surrounding pay and display car parks.

In addition to the above, in accordance with section 35 of the Road Traffic Regulation Act 1984, the local authority, subject to Parts I to III of Schedule 9 to this Act, may by order make provision as to—

- (i) the use of the parking place, and in particular the vehicles or class of vehicles which may be entitled to use it,
- (ii) the conditions on which it may be used,
- (iii) the charges to be paid in connection with its use (where it is an off-street one), and
- (iv) the removal from it of a vehicle left there in contravention of the order and the safe custody of the vehicle
